**4. FIRST-AID MEASURES**

### **5. FIRE-FIGHTING MEASURES**

### 6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures:	Eliminate all sources of ignition. Avoid contact with skin or inhalation of spillage, dust or vapor.
